IMPORTANT INSTRUCTIONS

1. Nomination Papers shall be proposed and seconded by Corporate Members whose names are present on the electoral roll. A Member can propose/second one number Chairman (of any division) and one number Vice Chairman (only of his own division). The nominations must be made for Chairman and Vice Chairman on the prescribed forms attached. The consent of the candidate shall be provided as per attached specimen.
2. No Member can propose or second his own candidature for any Office.
3. The **Chairman shall be a Fellow of the Institution for at least five years standing**. He shall be elected by the Corporate Members of his respective Local Centre. He should have been a member of the Council from that Centre for at least one term. He shall serve for maximum of two terms as Chairman in life time.
4. The **Vice Chairman of a Local Centre Division shall be a Fellow of the Institution** and registered with or attached to the respective Local Centre Division. He shall be elected by the Corporate Members registered with or attached to his respective Local Centre Division. He should have been a member of the Council from that Centre for at least one term.
5. All nominations must be accompanied with the Bank Draft or Pay Order in favor of **THE INSTITUTION OF ENGINEERS PAKISTAN, KARACHI CENTER** or IEP Karachi Center Cash Receipt paid by each candidate as Election Fee to IEP Karachi Centre for the posts of Chairman **(PKR.1000/-)** and Vice Chairman **(PKR.500/-)**. In case of more than one nomination of the same candidate for the same post, photocopies of the original payment receipt should invariably be attached with each subsequent nomination.
6. Bio-Data of candidates of 50 words for office of Chairman and 20 words for office of Vice-Chairman may be attached with nomination paper.
7. The Election Commission, IEP Karachi Centre will be the final authority for all matters related to the elections except appeals against results (if any).
