### IMPORTANT INSTRUCTIONS

The nominations must be made for Local Council Members on the prescribed forms attached. The consent of the candidate shall be provided as per attached specimen.
2. No Member can propose or second his own candidature for any Office.
3. Candidates contesting for seats of Local Council Members and their proposers/seconders must belong to the same Centre and Division. They shall be elected by Corporate Members of respective Center and Division.
4. All nominations must be accompanied with the Bank Draft or Pay Order in favor of **THE INSTITUTION OF ENGINEERS PAKISTAN, KARACHI CENTER** or IEP Karachi Center Cash Receipt paid by the each candidate as Election Fee **(PKR.100/- per candidate)** to IEP Karachi Centre for the posts of Local Council Members. In case of more than one nomination of the same candidate for the same post, photocopies of the original payment receipt should invariably be attached with each subsequent nomination.
5. Use additional sheet (as per attached format) in case the space for particulars of candidates is insufficient.
6. The Election Commission, IEP Karachi Centre will be the final authority for all matters related to the elections except appeals against results (if any).
